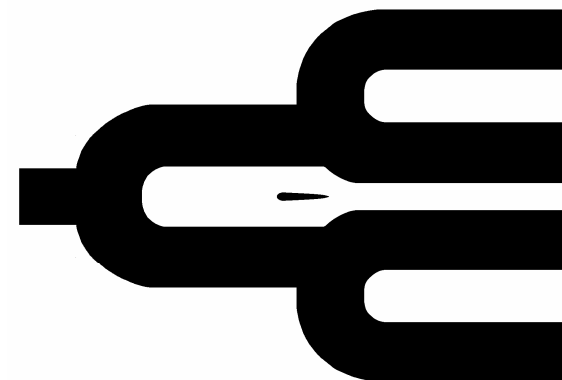
- Issues of *The New Zealand Genealogist* for the current year period of membership.

 - New Zealand resident members may borrow from the library at the Family Research Centre for the cost of postage.
